ADMINISTRATOR'S REPORT:

Administrator Entler expressed her gratitude to staff for all their hard work and dedication, noting that last week was Municipal Clerk's Week, this week is Police Week and next week is Public Works Week. In addition, Ms. Entler reported the following:

- The Circle Bridge will be closed on Saturday, May 18th for the "Brushes on the Bridge" public art event being held by the Forest Park Arts Alliance
- Administrator Entler and Forest Park elected officials traveled to Springfield to meet with legislators seeking grant funding for the reservoir replacement project.
- There was a very large water main break at Jackson and Hannah this past week.

COMMISSIONER'S REPORTS:

Commissioner Nero reported that the formerly vacant Bed, Bath and Beyond is being replaced with a new Aldi grocery store, Casa Humilde will be opening soon, now that their liquor license has been approved and Play it Again Sports is opening a new training facility. Last, the Parkway Dispensary on Madison Street should be opening soon. All of these new businesses will certainly rejuvenate the village.

Commissioner Melin-Rogovin reported about her trip to Springfield. In addition, the Public Works Team is working with the Vac Truck cleaning sewers and catch basins throughout town and the commissioner acknowledged their hard work. Repainting of street curbs has begun as well as preparation for the Brushes on the Bridge Community Art Project, which is this weekend. The commissioner reported that there will be a Juneteenth flag-raising ceremony on June 4th and Public Works Week is May 19th through 25th, including the annual electronics recycling event.

Commissioner Voogd reported that the Arbor Day tree was planted at Rieger Park on Arbor Day, however the ceremony will be held this Friday, May 17th in connection with the grand opening of Rieger Park. The commissioner commented on how nice it is to have the different taxing bodies working together. At the recommendation of the Morton Arboretum, the crews are covering newly planted trees with netting to protect against damage from cicadas. The village has over 3,000 trees, but only the younger trees risk permanent damage. The clean up event was a huge success, netting 30 bags of trash and shopping carts. The commissioner recognized both Alicia Hammond and Vicki Rakowski from the Library, for lending a helping hand. Commissioner Voogd reported meeting with Speaker Welch, Leader Harmon and attending an Environmental Commissioner meeting led by C-4 member Katrina Thompson. Last, the commissioner encouraged residents to volunteer for the Recreation Board to fill the vacancies.

Commissioner Maxham thanked the Chamber of Commerce for hosting the annual meeting last week. It was a great event, showcasing many Forest Park Restaurants that donated to the Taste of Forest Park. The commissioner reported a positive energy at the event and welcomed Casa Humilde to Forest Park. Last, the commissioner encouraged those interested to volunteer for the June 21, 2024, Pride event being held. The planning for this event is happening now.
